#### Wine Heritage

Update on the ACWHD 1<sup>st</sup> quarter payment status, noting 24 unpaid wineries and 53 paid wineries, totaling 77 wineries.

Collection fees with HDL, noting that they will not charge a 25% collection fee until further notice.

Amador County returned Operating Agreement by the Board of Supervisors is missing page, Megan will be going down to the County office after the meeting to pick up the signed copy.

#### Wine Institute

The CAWG meeting discussed a proposed bill to mandate that wines labeled as "American" in California must contain 100% American fruit, addressing current TTB standards that allow up to 25% foreign wine. The bill aims to enhance consumer transparency and support local growers. California produces over 80% of U.S. wine, and the bill could set a national precedent. Concerns about potential unintended consequences, such as wineries labeling as Chilean, were raised. The bill's enforcement would involve the Alcohol Beverage Control (ABC) investigating complaints. Feedback from regional representatives will inform the next steps, including potential legislative action.

#### **Barbera Festival**

Hired an event coordinator to handle logistics surrounding Barbera Festival.

#### **Funds**

Timeline for moving accounts from the AVA to the AWHD and the process for returning pro-rated dues will be set for June 30, 2025.
